Action by Unanimous Written Consent

OF THE BOARD OF DIRECTORS

July 17, 2024

In accordance with Section 141(f) of the Delaware General Corporation Law and the Bylaws of Bleedio Tech, Inc, a Delaware corporation (the “**Company**”), the undersigned, constituting all of the members of the Company’s Board of Directors (the “**Board**”), hereby take the following actions and adopt the following resolutions by unanimous written consent without a meeting:

WHEREAS, the Board desires to grant a Non-Statutory Stock Option to Brad Niems in connection with his engagement as Chief Revenue Officer (Adopted Co-founder) of the Company pursuant to a Consulting Agreement dated July 17, 2024 (which Consulting Agreement describes the engagement scope as “VP of Technical Sales Functions” in Exhibit A thereof);

WHEREAS, by Action by Unanimous Written Consent dated June 5, 2024, the Board adopted the 2024 Stock Option Plan (the “Plan”) and confirmed that the fair market value of the Company’s Common Stock was \$0.001 per share, and established a minimum exercise price floor of \$0.01 per share (ten times the fair market value) for all stock option grants under the Plan, providing a substantial cushion above fair market value under Section 409A of the Internal Revenue Code, in each case until a new fair market value determination is made by the Board;

WHEREAS, on July 11, 2024 (six (6) days prior to the date hereof), the Company issued a Simple Agreement for Future Equity (“SAFE”) to Prox SG Pte. Ltd. in the principal amount of \$100,000 at a \$2,000,000 post-money valuation cap, and the Board has specifically considered whether the issuance of the SAFE constitutes a material change in the Company’s financial condition, operations, or prospects that would require a revised fair market value determination prior to this grant;

WHEREAS, the Board notes that the SAFE valuation cap is not a per-share price for Common Stock and is not equivalent to fair market value of Common Stock, as Common Stock is subject to significant discounts relative to SAFE valuation caps given liquidation preferences, conversion features, and the early stage of the Company; and the SAFE was issued from a closely-affiliated party (Prox SG Pte. Ltd. is the engineering services provider founded and controlled by the Company’s technical co-founder Mikhail Kolobov), and as such does not constitute a fully arms-length priced equity transaction; and the Company remains pre-revenue, the SAFE has not converted, no priced equity financing has occurred, and no independent 409A appraisal has been obtained;

WHEREAS, based on the foregoing, no new fair market value determination or independent 409A appraisal has been made since June 5, 2024, and the Board

confirms that the July 11, 2024 SAFE issuance does not constitute a material change requiring a revised determination prior to this grant;

NOW, THEREFORE, BE IT RESOLVED as follows:

1. Stock Option Grant — Brad Niems

RESOLVED: That the Company hereby grants to Brad Niems a Non-Statutory Stock Option to purchase 20,600 shares of the Company's Common Stock under the 2024 Stock Option Plan, at an exercise price of \$0.01 per share (being ten times the fair market value of \$0.001 per share as determined by the Board on May 30, 2024 and confirmed on June 5, 2024, and providing a substantial cushion above fair market value under Section 409A of the Internal Revenue Code), with a grant date of July 17, 2024, a Vesting Commencement Date of July 17, 2024, and expiration 10 years from the grant date (July 17, 2034), vesting over four years with a one-year cliff (25% of shares vest on the first anniversary of the Vesting Commencement Date; the remaining 75% vest in equal monthly installments over the following 36 months), and subject to double trigger acceleration upon both (a) a change of control of the Company and (b) termination without cause or resignation for good reason within twelve (12) months thereof (this twelve-month period being the "specified time frame" referenced in Exhibit B of the Consulting Agreement); and that the Chief Executive Officer is authorized and directed to execute and deliver to Mr. Niems a Stock Option Agreement consistent with the foregoing terms and the Plan.

2. Omnibus Resolution

RESOLVED: That each of the officers is authorized and empowered to take all such actions (including, without limitation, soliciting appropriate consents or waivers from stockholders) and to execute and deliver all such documents as may be necessary or advisable to carry out the intent and accomplish the purposes of the foregoing resolutions and to effect any transactions contemplated thereby and the performance of any such actions and the execution and delivery of any such documents shall be conclusive evidence of the approval of the Board thereof and all matters relating thereto.
